# ARA REALTOR® APPLICATION

## MEMBERSHIP REQUIREMENTS

1. A completed membership application submitted to ARA.
2. Membership Fees must be paid.\*
3. Attendance at an in-class ARA Local Orientation course offered by the Atlanta REALTORS® Association. This must be completed within 6 months of submitting your application to ARA. Scheduled dates and times of these classes can be found online at [www.atlantarealtors.com/orientation](http://www.atlantarealtors.com/orientation).
4. Completion of a qualified New Member Code of Ethics course within 6 months of submitting your application to ARA. For more information, please visit [www.atlantarealtors.com/orientation](http://www.atlantarealtors.com/orientation).
5. If you are currently a member of another association or have held membership in the past in the Atlanta REALTORS® and have already completed a New Member Orientation Course, then you do not need to attend one again. You must submit proof of your orientation completion from your previous association in order to bypass these requirements.
6. **Note - Designated REALTORS®** - Membership fees must also be paid per licensed agent within the company. Paying fees on agents within an office does not automatically qualify them for membership; each agent must complete an application and fulfill all necessary requirements.

## ARA DESIGNATED REALTOR® / REALTOR® FEE INFORMATION

Annual membership fees for the Designated REALTOR® are calculated at \$450.00. Each licensed agent within the Designated REALTORS® office will also pay \$450.00 in order to become a REALTOR® member of ARA. All agents applying to ARA must pay the fees, fill out an application, attend an Orientation session and complete REALTOR® Code of Ethics training before being approved for full membership.

The portion of dues paid that is spent to lobby the State and Federal governments is not deductible for income tax purposes. GAR has estimated that \$10.41 (10.62%) is the nondeductible portion of 2020 GAR dues. NAR has estimated the nondeductible portion of its 2020 dues to be \$57.00 (or 38%). The entire \$35.00 NAR Consumer Advertising Campaign Assessment qualifies as deductible dues.

**DESIGNATED REALTOR®** - Defined as the Principal Partner, Corporate Officer, Trustee, or Branch Manager of a Real Estate firm. There is only one Designated REALTOR® per company. The Designated REALTOR® is responsible for paying fees for all licensed agents within his or her organization.

**REALTOR®** - Defined as any agent within the office of a Designated REALTOR® that holds an active real estate license who becomes a member of ARA.
